

# **TREATY OF AMITY AND ALLIANCE BETWEEN THE GOVERNMENTS OF THE KINGDOM OF UNITED COUNTIES AND THE IMPERIAL STATE OF SMYRNA**

*Effective as of 1 November 2018*

*WHEREAS the Governments of the Kingdom of United Counties and the Imperial State of Smyrna initiate this Treaty of Amity (hereinafter ‘the Treaty’) which is based on the principles of equality, mutual benefit, and fairness.*

*THE GOVERNMENTS are also determined to reinforce the communications between both peoples in the fields of politics, economy and culture, to obtain better societies, and to preserve the peace, prosperity, and stability of the world thereupon this Treaty as follows is ordained and shall be obeyed by both Governments and peoples faithfully and perpetually.*

## **ARTICLE I**

Since this Treaty is signed and exchanged by Principle Representatives from both Governments and subsequently the Treaty becomes in effect, the diplomatic relationship between both Countries is hereby established, and both Countries are authorized to establish embassies and consulates mutually.

## **ARTICLE II**

This Treaty will only be verified and become valid by being confirmed by the Royal Assent and parliamentary approval of the Kingdom of United Counties, and the authorization from the Governor General of the Imperial State of Smyrna on behalf of Her Majesty the Queen.

## **ARTICLE III**

All treaties, agreements and arrangements that are confirmed by both High Contracting Parties prior to the effective date of this Treaty will remain valid.

In accordance with the aforementioned documents and this Treaty, both High Contracting Parties hereby guarantee to reach their best performance and to their best power to enhance the political, cultural and economical communications, between both High Contracting Parties.

## **ARTICLE IV**

When the occasions of severe disasters occurred, or being in the state of war in either High Contracting Parties, the other High Contracting Party in this Treaty has the responsibility to provide assistance to the rehabilitation of that country concerned.

However, if the aforementioned 'state of war' is caused by an invasion to the third party, or an offence to the intermicronational laws and treaties, the preceding clause shall be null and void.

## ARTICLE V


Both High Contracting Parties must confirm that this relationship established is based on the principles of mutual non-interference in the other's internal affairs and the universal values of the supremacy of human rights, consisting freedom, democracy and people's livelihood.

This present Treaty shall come into force immediately upon its ratification.


IN FAITH WHEREOF the Principle Representative and the Plenipotentiary have signed the present Treaty and affixed thereto their seals.
